GENERAL INSTRUCTIONS

Any person wishing to register Savannah goats in NASA at the prices listed on Work Order & Fee Schedule must be a NASA member with the current years' dues paid in full. Non-members may register and transfer but non-member fees will be charged.

Registration

Registrations for Savannah goats must be submitted to the NASA office, located in Milo, IA as part of Associated Registries, on the appropriate forms and with correct fees included. The owner of the kid at the time of birth is responsible for registering. New forms will be returned with each set of work mailed in.

I. Fullblood Animals

Savannahs that are of full South African ancestry and accompanied by appropriate Kifaru sales receipts or South African Embryo Transplant and importation documents will be accepted as fullbloods in the NASA registry. Only Fullblood bucks mated to Fullblood does can produce Fullblood offspring.

Their registration number is preceded by the prefix BF (Fullblood Buck) and **DF** (Fullblood Doe).

*A Fullblood registered in any Savannah association besides NASA, can only be entered as a Purebred in NASA.

II. Purebred Animals

A. Buck kids (that will be registered as 96%) registered out of does of at least 93%, will be designated as "Purebred" and 100% will be used to calculate the percentage of their offspring. **Their registration number is preceded by the prefix BP** (Purebred Buck).

B. Doe kids that will be registered as 93% will be designated as "Purebred" and 100% will be used to calculate the percentage of their offspring.

Their registration number is preceded by the prefix DP (Purebred Doe).

*A Fullblood registered in any Savannah association besides NASA, can only be entered as a Purebred in NASA.

C. Examples of matings that will produce "Purebred" Bucks and Does include:

III. Percentage Animals

Buck kids registered at 93% or below and Doe kids registered at 87% or below.

Their registration number is preceded by the prefix BX (Percentage Buck) and **DX** (Percentage Doe).

Registration/Transfer & Other Fees

Please see the Work Order & Fee Schedule to help figure pricing and total to mail with work. If registering and transferring at the same time, both a registration fee and a transfer fee must be paid.
