Persons listed as Co-Owner will be listed on the MSCA registration documents as part Owner, but will not be authorized to sign any MSCA documents pertaining to said dog or litter.

FULL or LIMITED Registration is determine3d by the litter Breeder. Onlyh the Breeder checks the box for eithe rFull or Limited registration status of each puppy on the Litter Registration Record Form as well as on the Individual Registration Application Form for each pupppy.

FULL REGISTRATION: The dog is registered with no restrictions. Offspring of the dog may be registered.

LIMITED REGISTRATION: The dog is registered but no litters produced by that dog are eligible for registration. No offspring of a dog that has Limited Registration is elible for registration. Each registration certificate for such dog shall indicate Limited Registration. Limited Registration can be changed to Full Registration only by the litter Breeder. To change the registration status of a dog, the Breeder must complete and submit an "Application to Revoke Limited Registration Status" to MSCA along with the required fee. After processing, a Full Registration certificate will be sent to the

**Limited Registration helps breeders protect their breeding programs. If a breeder does not want certain puppies used for breeding purposes, they can request the Limited Registration option for said puppies.
