## **REGISTRATION STATUS**

FULL or LIMITED Registration is determined by the litter Breeder. Only the Breeder checks the box for either Full or Limited registration status of each puppy on the Litter Registration Record Form as well as on the Individual Registration Application Form for each puppy.

- **FULL REGISTRATION:** The dog is registered with no restrictions. Offspring of the dog may be registered.
- **LIMITED REGISTRATION:** The dog is registered but no litters produced by that dog are eligible for registration. No offspring of a dog that has Limited Registration is eligible for registration. Each registration certificate for such dog shall indicate Limited Registration. Limited Registration can be changed to Full Registration only by the litter Breeder. To change the registration status of a dog, the Breeder must complete and submit an "Application to Revoke Limited Registration Status" to the MSCA along with the required fee. After processing, a Full Registration certificate will be sent to the dog's owner.

***Limited Registration helps breeders protect their breeding programs. If a breeder does not want certain puppies used for breeding purposes, they can request the Limited Registration option for those puppies.***
