Work Order Instructions

1. Fill out personal information
2. Memberships (membership # will be assigned by Associated Registry)
 - Adult :Annual Flock Member - Select if you are a breeder/owner
 - Associate Member - (social) an admirer who would like to be involved with the registry and participate in all activities.
 - Junior: Annual Flock Member - Must be under the age of 21.
3. Registrations - See breed up rules below.
4. Transfers - Transfer of ownership (original certificates must be mailed in with work order)
5. Flock Prefix Listing - Must be 3-5 letters, may be an abbreviation of your name, farm name, or other. Must provide a first and second choice. No charge for flock prefix, no charge for lamb name.

Registration Classification and DNA Verification Requirement

(supporting information for #11 on registration application)

- Fullblood: Must have originated from 100% fullblood stock either imported or born in the USA. Certificate of registry on gold color paper.
- American Purebred Ewes/Ram: must have a minimum of 93.75% (ewe) and 96.875% (ram) and less than 100% Valais Blacknose blood originating from any combination of Fullblood, American Purebred, or American Percentage parents. Certificate of registry on white color paper.
- American Percentage Ewe/Ram: must have minimum of 25% (ewe) and 50% (ram) and less than 93.75% (ewe) and 96.875% (ram) Valais Blacknose Sheep blood originating from any combination of Fullblood, American Purebred, or American Percentage parent. Certificate of registry on grey color paper.
- Ewes less than 25%, rams less than 50%, and wethers are ineligible for registration but are eligible for “Record of Pedigree” certificate. Certificate of record on grey color paper.
- Registration of Imported Fullblood (live or ET)—in addition to DNA marker testing for parent verification and application of registration, must submit 3 generation of individual or sire and dam, respectively. Extra cost for Import Fullblood is for data entry of pedigree.
- DNA Parent Verification: All lambs/sheep submitted for registration must be DNA marker tested for parent verified at an accredited national or international lab for ovine (sheep) DNA parent verification. No one lab is required for DNA parent verification as long as lab is accredited, and test verification meet the following criteria.
 - a) Dam, Sire, and offspring for parent verification must have DNA marker testing on file at the same lab for parent verification. No cross lab use for DNA marker testing to verify parentage (i.e. Dam cannot be at one lab and/or a Sire and/or offspring at another lab)
 - b) DNA parent verification for the animal being registered must be submitted on official accredited lab letterhead and signed by verifying lab/company with registration application.
 - c) It is the responsibility of the breeder and/or owner of animal to provide DNA marker testing of dam, sire, and offspring for parental verification at an accredited lab for registration. For individuals marketing semen and/or embryos, and/or leasing animals it might be in the best interest to bank the DNA marker at multiple labs where offspring and/or ewes may be tested.
 - d) Any non-Valais Blacknose sheep influenced animal (foundation ewes) or wethers (castrated males) need not present a DNA marker verification.
