No separate application is required. Your transfer information will be recorded in the registry database, and your certificate will be signed, dated, and returned to you.

New Registrations

Note: lambs are born in 2012 must be registered on or before December 31,2021 in order to recieve the \$7.00 registration fee. A sheep that is registered after its year of birth is subject to a registration fee of \$10.00.

Sheep Registration Application

- The registration application allows you to enter up to 7 sheep on one page. The first entry (in red) is an example entry.
- Enter the name of the Sheep or Lamb (optional).
- Enter the ear tag number. REQUIRED. Any ear tag or tattoo that identifies this sheep as an individual is acceptable. For example, you may use its USDA Scrapie Tag number, or a farm ear tag number. For more information about the Federal Scrapie Eradication Program, and associated ear tags, please contact your state veterinarian. Applications lacking ear tag or tattoo number will be returned to the applicant for completion.
- Enter the animal's sex (R=Ram; E=Ewe; W=Wether).
- Enter the animal's date of birth.
- Enter type of birth (single, twin, triplet).
- Enter the animal's color (B=Black; W=White; D=Dilute).

- Enter the AMCSBA registration number of the sire.
- Enter the AMCSBA registration number of the dam.

NOTE: This registry only accepts offspring of registered parents. Please enter the parents registration numbers. If registered with a different miniature Cheviot registry, please include the name of that registry. The registrar reserves the right to review, and accept or deny registrations deemed inconsistent with registry rules and breed standards.
