Please Note: A FBA registration number will be issued on certificates, but no ear tags will be furnished. The FBA registration number and individual ID (ear tag or tattoo) number must always remain the same and cannot be changed. Never use the same number on two different animals. If a sheep loses an ear tag, you may re-tag the sheep with a different tag number and keep this information in your flock records as required by USDA regulations. However, continue to use the sheep's original ear tag number (as recorded on its FBA Certificate of Registry) for the purpose of registering its offspring. The FBA will furnish suggestions for tagging and/or identification upon request. Once registration papers are received, it is breeder responsibility to ensure all information is accurate. It is the responsibility of the breeder to register animals, and is not able to be done by anyone other than the owner of dam at time of mating.

Docked Tails: Finnsheep with docked tails will not be registered. The tail is a distinct characteristic of the animal's/breed's purity.

Pattern/ Marking Classification: Please see the Color and Marking Guide on the FBA website for guidance in registering colored sheep. Email the FBA for further clarification if needed.
